Mandhana, Mr. Jeenendra Bhandari, Mr. Chandrakant Shetty and Mr. Pandhariath Parab ceased to be the Directors w.e.f 25-09-2017. Hence the Audit Committee, Nomination and Remuneration Committee and Stakeholders' Relationship Committee stands dissolved as on date. On 28-09-2017 Mr. Laxman Kamble, Mr. Yogesh Hate and Mr. Manish Hate vacated the office of the Directors pursuant to Section 167 of Companies Act, 2013 and thereafter Mr. Purushottam C. Mandhana, Mr. Manish B. Mandhana and Mr. Monarch Gandhi were nominated by Promoters of the Company pursuant to sub-Section 3 of Section 167 of the Companies Act, 2013. Hence the Company as on date does not have Independent Directors and Woman Director.

On 29-09-2017 National Company Law Tribunal, Mumbai Bench has admitted the reference for initiation of Corporate Insolvency Resolution Process under Insolvency and Bankruptcy Code, 2016 and thereby the powers of the Board of Directors stand suspended with effect from that date.
